## **LEGISLATION SUPPORTING OUR TROOPS AND HONORING OUR VETERANS**

### **Property Tax Exemption**

Annual proof of disability is no longer required to claim the disabled veterans' property tax exemption. Regardless of age or disability rating, any veteran who submits initial proof to the town assessor must only do so again if the VA modifies the rating.

### **Military Family Relief Fund**

The Military Department uses grants from this fund to pay for essential personal or household goods or services, if paying for them is a hardship because of a member's service. Immediate relatives of armed forces members living in-state are now eligible, regardless of whether the service member is active-duty or not.

### **College Tuition Waiver**

National Guard members who are part-time students in the Connecticut State University System are now eligible for a tuition waiver. If tuition exceeds the amount of benefits under the new G.I. Bill, the college will waive the remainder.

### **Gravestones and Flags**

In past years, there had been occasional conflicts when the placing of flags at veteran's graves had interfered with the maintenance and mowing of cemeteries. Paying respect to those who sacrificed their lives for our country should not be hindered in any way, so there can be no restrictions on the placement of U.S. flags on veterans' graves from the Saturday before Memorial Day until the Monday after July 4<sup>th</sup>.

### **Cell Phone Ban**

Armed Forces members may now use their hand-held mobile phones while driving on a highway, if they are in a military vehicle performing official job duties.

### **Wartime Service Medals**

These medals are awarded to veterans who were called into service as a Connecticut resident. Medals may now be awarded posthumously to veterans who died on or after January 1, 2000.
