## PROTECTING OUR ENVIRONMENT

- Set a goal of reaching zero greenhouse gas emissions from electricity supplied to you by 2040
- Expanded financing to develop zero emission vehicle infrastructure, build more solar power and fuel cells, and reinforce our electric grid against the effects of climate change
- Required the installation of electric chargers at new state and commercial buildings while exempting electric charging stations from property tax assessments
- Supported developing carbon-neutral plans for new transportation projects
- Created new incentives for consumer and commercial electric vehicles
- Incentivized school districts to use electric school buses



## YOUR PRIORITIES

You told me what was most important to you; here’s what we did to answer your calls:

### Responding to the Kids’ Mental Health Crisis

- Provided grants to local schools to hire more support staff, including in the areas of mental health: social workers, psychologists, and counselors
- Created new walk-ins for mental health emergencies
- Expanded 24/7 emergency mental health response

### Improving Access to Quality Health Care

- Expanded screenings for breast and cervical cancer
- Ensured more psychiatric treatment beds
- Expanded eligibility to perform abortion care to include advanced nurse practitioners, nurse midwives, and physician assistants

### Education & Early Childhood Initiatives

- Established new reimbursement grant to assist schools in upgrading their HVAC systems, and ensured regular inspections and reporting on their operation
- Increased pay to childcare workers to attract and retain more educators
- Expanded successful Birth to Three Program
