Dear Friends and Neighbors,

As of April 1st, all Connecticut residents age 16 and above are eligible for the COVID-19 vaccine.

There are five conditions that qualify people for "accelerated access" to COVID-19 vaccinations. They are: sickle-cell disease, end-stage renal disease, active cancer (in treatment), solid organ transplant, and down syndrome. This program will make it easier for this group to schedule appointments and access to an allocation of doses. The state is also planning separate, designated clinics for people with intellectual or development disabilities.

The VA Connecticut Healthcare System is also providing the COVID-19 vaccine to all military veterans (regardless of VA enrollment status), and spouses and caregivers of veterans. I am proud to have helped push for this policy. No appointment is needed, but you can make one by calling 203-932-5711, ext. 5627, 7784, or 7754.
