

MONEY FOLLOWS THE PERSON

Money Follows the Person Project was the centerpiece of my legislative activity this session. Money Follows the Person is a five year program that permits states to move individuals out of nursing homes or other institutional settings and into less restrictive community environments. Effective July 1, the number of individuals participating in the program will be increased from 700 to 5,000. PA 08-180

HOME CARE FOR THE DISABLED

This act increases the asset limits in the state funded, pilot home and community based services program for adults under age 65 who have disabilities. The increases for 2008 are \$20,880 to \$31,320 for a single person and \$31,320 to \$41,760 for a married couple. PA 08-88

RESPONSIBLE LENDING AND ECONOMIC SECURITY

With the number of foreclosures on the rise in Connecticut, the General Assembly has acted to protect the rights of homeowners, keeping families in their homes without discouraging responsible lending.

HB 5577 includes a comprehensive set of reforms that will provide mediation and financial assistance to individuals and families whose homes are at risk of foreclosure. The bill creates stricter regulations and greater penalties on lenders and brokers when writing loans for people with limited income and high debt.
