



The 2024 legislative session is in the books and I am proud of what we accomplished.

Last year's Biennium Budget laid the foundation for this year's priorities. We focused on big issues in 2024: elder care, protecting healthcare workers, childcare, early childhood nutrition, climate change, paid time off, targeting street takeovers - all while remaining within our fiscal guardrails.

A key piece of legislation leveraged federal ARPA funds for unprecedented investment in major areas: higher education, early childcare, mental health, and nonprofits. Additionally, we closed this fiscal year with a \$270 million operating surplus after depositing \$1.1 billion in the Rainy Day Fund and our pension systems. Connecticut continues to critically invest in common goods while retaining the largest tax cuts in state history.

# PROTECTING TAX CUTS

WE PASSED A BIPARTISAN BIENNIUM BUDGET THAT INCLUDES HISTORIC TAX CUTS AND INVESTMENTS FOR OUR COMMUNITY.

- LARGEST INCOME TAX CUT in state history
- Biggest investment in public education ever
- New supports for the IDD community
- Expansion of debt free community college
- Protected safety net programs

## THIS SESSION WE PROTECTED THESE TAX CUTS AND INVESTED MILLIONS OF FEDERAL FUNDS IN:

- Higher Education \$160 million with a path to grow to \$200 million
- Early Childcare \$21.8 million
- Mental Health \$24 million
- Nonprofits \$50 million

### **SUPPORTING OUR VETERANS**

- Exempted permanently and totally disabled veterans from paying property taxes. (PA 24-46)
- Made it easier for veterans to earn a Q license endorsement to join fire departments. (PA 24-14)
- Expanded eligibility for grants from the Military Relief Fund for families experiencing hardship. (PA 24-57)
- Expanded veterans' driver's license and license plate options to reservists. (PA 24-146)
- Formally recognized Vietnam veterans who were exposed to Agent Orange. (SJ 6)

### **KEEPING CONNECTICUT HEALTHY**

- Allowed telehealth to continue for in-state and out-of-state residents without letting the practice sunset. (PA 24-110)
- Protected home health care workers with funding for safety escorts and technology. (PA 24-19)
- Required railroads to develop annual plans on the impact of pesticides on vegetation management & highlight herbicide use in their operational plans.
- Covered victims of sexual assault under the state's Paid Family & Medical Leave program. (PA 24-5)
- Banned paperwork requirements for receiving critical ambulance rides. (PA 24-19)
- Banned numerous products containing dangerous PFAS chemicals. (PA 24-59)

### **FUNDING FOR OUR COMMUNITY**

- \$5,000,000 to restore services on the Shoreline East Rail Line.
- **\$5,224,415** potential reimbursement to the Town of Groton for the construction of a microgrid at the U.S. Naval Submarine Base.
- \$2,000,000 to the New London Early Child Learning Center at B.P.
- \$2,000,000 for the TVCCA's Groton Early Childhood Education Center.
- \$1,620,000 for the completion of the Lyman Allyn Park.
- \$1,000,000 to New London for Magnet School costs.
- **\$63,296** increase to Tri-Share PILOT Program in Eastern Connecticut to cover participating employee's childcare costs.









### **INVESTING IN EDUCATION**

- Directed the Office of Early Childcare to establish the Tri-Share Child Care Matching Program as a pilot initiative in New London County with childcare expenses for participants split evenly between employee, employer, and the state.
- Established the Education Mandate Review Advisory Council to review proposed and existing mandates on local boards of education. (PA 24-45)
- Required same day parental notification when children hurt themselves or others. (PA 24-93)
- Capped the amount of money all districts pay to send kids out of district – saving millions of dollars for local schools. (PA 24-81)
- Required the State Department of Education to provide school districts an estimate of their next year's funding by the end of the current year, to ensure better budgeting. (PA 24-81)
- Provided help to classroom paraeducators to pay for their health insurance. (PA 24-81)

### **CARING FOR SENIORS**

- Expedited Medicaid coverage for home-based care as an alternative to more costly nursing home care. (PA 24-39)
- Created a new registry system to connect patients to home care providers and created a dashboard to help navigate nursing home options. (PA 24-39)
- Required nursing homes and retirement communities to provide at least 60-90 days' notice of any fee increases and improved transparency around fees. (PA 24-141)
- Created an incentive-based program to improve nursing home care in CT. (PA 24-141)
- Fast-tracked nursing home transfers and receiverships when homes are closing. (PA 24-141)
- Required health insurance coverage for detecting coronary artery disease. (PA 24-19)
- Strengthened oversight of negligent nursing homes. (PA 24-141)
