HUSKY Care



I am Proud To Have Worked On These Issues:

PROTECTING PRE-EXISTING CONDITIONS: The legislature passed HB 5521, which expands on existing law. This bill puts the ACA protections for pre-existing conditions into statute. Additionally, this legislation includes short term health plans and conditions previously not receiving medical treatment. This bill ensures that people in Connecticut with pre-existing conditions will be protected.

MENTAL HEALTH PARITY: I recognize that CT needs to do better on mental health and substance abuse disorder, and make mental health treatment accessible. Legislation has been introduced requiring that health insurance companies treat mental health issues in the same way that they treat physical health.



HEALTH INSURANCE COST-SHARING: A new law limits the maximum out-of-pocket expenses that certain health insurers may charge such as co-payments, co-insurance and deductibles. Under this law, health insurance plans cannot impose cost-sharing that exceeds (1) the amount paid to the provider for the covered service, (2) an amount calculated based on how much the provider charges, or (3) the amount an insured would have paid to the provider without using their insurance.

COVERAGE FOR HEARING AIDS: This bill eliminates an age restriction for mandated health insurance coverage for hearing aids, thus requiring certain insurance policies to cover hearing aids for any covered person.

BREAST IMAGING: The Governor signed a bill into law which will prohibit the charging of a co-payment, cost-sharing, applying to a deductible or charging of a facility fee for both routine and baseline mammograms and breast ultrasounds for breast cancer screenings.

PAID FAMILY MEDICAL LEAVE: This program ensures that no one should have to choose between work and taking time off to care for a new child, a family member with a serious health condition, or their own serious health issue. The legislation will provide up to 12 weeks of wage replacement benefits for state residents who are eligible.

RAISING THE SMOKING AGE: A new law increases the legal smoking age from 18 to 21. This applies to cigarettes, other tobacco products, and electronic cigarettes.

MEDICARE SAVINGS PROGRAM: The State of Connecticut offers financial assistance to eligible Medicare enrollees through our 'Medicare Savings Programs.' These programs may help pay Medicare Part B premiums, deductibles and co-insurance. In this year's budget we made sure to protect this program.
