With the pandemic at the forefront of our minds for nearly two years, we have seen the importance of encouraging people to seek out medical care and services as soon as it is needed, and the vital role elections play in our democracy. During the 2021 Legislative Session, we took important steps to improve the health of our democracy and of every person we represent. Connecticut led the charge in protecting the voting rights of all residents by passing two resolutions to amend our constitution and passing more immediate measures to expand voter access and ensure that voting in Connecticut is easy, convenient and equitable. KEEPING CONNECTICUT FAMILIES HEALTHY AND SAFE

- Set minimum standards for long-term care insurance

EARLY VOTING & NO EXCUSE ABSENTEE VOTING

This session we approved a resolution that lets voters decide if CT will join 43 other states in allowing early voting. The question will appear on the 2022 ballot. We're also putting the question to voters in 2024 whether any registered voter should be allowed to vote by absentee ballot without needing an excuse.

- Guaranteed two hours off from work to vote in state and federal elections
- Paved the way for permanent drop boxes for absentee ballots
- Protected voters' personal information
