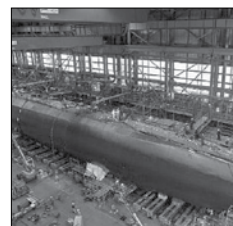
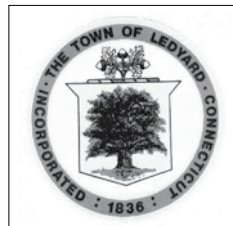

## THIS SESSION I AM PROUD TO SUPPORT:

- **SB 5 AN ACT CONCERNING A WORKFORCE PIPELINE AND JOB CREATION.** This bill would prepare our future workforce for high-paying manufacturing and technical jobs.
- **SB 3 AN ACT COMBATTING SEXUAL ASSAULT AND HARASSMENT.** This would enhance prevention and punishment for sexual assault and harassment.
- **HB 5499 AN ACT PROMOTING CRAFT BREWERIES AND PRICE FAIRNESS.** This would allow local breweries to sell more of their products directly to their customers.
- **HB 5005 AN ACT PROMOTING SMALL BUSINESSES.** This bill would streamline government services and expand access to capital for small businesses.
