# WE'VE GOT YOUR BACK: REAL SUPPORT FOR ALL CONNECTICUT FAMILIES

## I AM PROUD TO HAVE SUPPORTED THE FOLLOWING NEW LAWS TO HELP CONNECTICUT FAMILIES:

- Fully funded free community college – meaning students can work on their associate degrees without having to pay tuition out of pocket (PA 21-2)
- Required employers to provide a salary range for job openings – making sure you don't waste your time on jobs that won't pay the bills; and that your salary negotiations are based on what the job is worth, not what you've been paid in the past (PA 21-30)
- Eliminated state income taxes on IRA income over time, beginning in the 2023 tax year (PA 21-2)
- Provided more low-income families a break on their state income tax through the Earned Income Tax Credit (PA 21-2)
- Strengthened the rights of families who are not biologically related and for parents who have children through the assistance of donors (PA 21-15)
- Provided legal representation to those facing eviction (PA 21-34)
- Repealed the poverty tax to stop the state from taking back assets when someone fights their way out of poverty (PA 21-3/PA 21-2)
