# REPRESENTATIVE COOK DELIVERS THE LARGEST TAX CUT IN STATE HISTORY



## OUR STATE BUDGET INCLUDES \$650 MILLION IN TAX RELIEF

- Increased state income tax credit for property owners from \$200 to \$300
- Reduced mill rate cap from 45 to 32.46 for the car tax
- Extended tax cuts for workers in low-paying jobs (EITC)
- Increased funding for our community non-profits
- Extended the 25-cent cut to gas tax and free bus service until December
- Established a state child tax credit for income-eligible taxpayers for up to 3 dependent children under age 16
- Made a \$3.5 billion payment to CT's pension debt, saving taxpayers considerable money
- Lowered the business tax rate for Unemployment Insurance, effectively making the federal loan repayment for the coming year on behalf of businesses

## WITH ADDITIONAL FUNDS FOR:

- **\$179,575,000** for construction of the new Torrington Middle and High School, representing a reimbursement rate of 85 percent
- **\$100,000** for the Sullivan Senior Center and **\$81,367** for the Torrington Fire Training School
