Call the 211 Infoline

- » Infoline is a toll-free help line that is available 24 hours a day.
- » It's the confidential, free and multilingual way to locate services in your area—legal assistance, child care services, elder care, energy assistance, suicide prevention, eligibility requirements for state programs, substance abuse, domestic violence, etc.
- » Caseworkers are trained in crisis intervention.
- » Infoline is not for emergency police, fire or medical assistance.

Help with Prescription Drug Coverage

ConnPACE Plus helps senior citizens and people with disabilities pay for prescription drugs. You must meet certain income conditions, but if qualified ConnPACE can help with prescription co-pays and pay Medicare part B premiums.

Weatherize your Home

Qualifying Connecticut residents may receive up to \$6,500 for weatherizing their homes. Both homeowners and renters are eligible to apply for services, which include things like better insulation and windows. Any household at or below 200% of the poverty level is eligible for this program. 800.842.1132

Free Legal Services

Statewide Legal Services provides free legal advice on matters ranging from housing problems to bankruptcy. They can make referrals if you require legal representation. 800.453.3320

Credit Counseling
