

#### HISTORIC FUNDING FOR LOCAL SCHOOLS

Invests over \$240 million in public education for the 2024-25 school year:

- Capped tuition payments for local districts on choice programs resulting in \$11.4m in new funding for Open
- \$164m in new funding to local boards of education
- \$9.3m in new funding for charter schools
- \$53.3m in new funding for magnet schools
- \$7.2m in new funding for VoAg programs

## LARGEST TAX CUT IN STATE HISTORY



#### **SUPPORTING SENIORS**

- Memory Care: Expanded eligibility for seniors to participate in adult day services (serving those with early onset dementia)
- Medicaid Expansion: Increased Medicaid coverage for services like primary healthcare, physical therapy, and meals
- Fraud Protection: Allowed banks to freeze transactions when they suspect a senior is being scammed
- Eliminated Even More Taxes on Retirement:
  - Increased phase out of tax on IRA income for those making \$75K or less annually (\$100K for joint)
  - Extended exemptions to remove the income cliff, by phasing-out tax on income up to \$100K or \$150K for joint filers by increasing the deduction between 2.5% and 100% depending on your income



#### **CONTINUING FISCALLY RESPONSIBLE BUDGETING**

- Deposits \$3.3 billion into Rainy Day Fund keeping our credit ratings high and preparing us for any potential economic downturn
- Keeps us under the constitutional spending cap in both years following the financial guardrails
- Eliminates our use of federal COVID relief money to balance our budget
- Reduces the state income tax by lowering the 5.0% rate to 4.5% and the 3.0% rate to 2.0% for the income year 2024. The benefits will be capped at \$150,000 for single filers and \$300,000 for joint filers
- Benefits one million tax filers with the rate cuts nearly 60% of all filers

# & PROTECTING THE ENVIRONMENT

- Updated permitting process to protect locations that have historically dealt with high levels of pollution
- Protected migratory birds by requiring state-owned and leased buildings to turn off unnecessary outdoor lighting
- Responded to the municipal solid waste crisis with new funding for facilities and mandatory food scrap diversion programs
- Provided additional funding for PFAS remediation

## CONNECTICUT GUN CONTROL REFORMS

- Restricted open carry
- Banned ghost guns and closed existing loopholes
- Limited monthly handgun purchases to 3 per 30-day period
- Required safe storage and trigger locks
- Expanded our assault weapon
- Updated training requirements
- Strengthened penalties for failure to report lost or stolen guns

## SUPPORTING WORKERS & SMALL BUSINESSES

- Streamlined statutory business reporting requirements
- Supported CT farm wineries by allowing them to open up retail
- Protected workers whose health benefits are terminated during labor disputes
- Established tax credit for businesses that expand childcare for employees
- Facilitated bidding process for smaller contractors on state projects
- Expanded JobsCT to promote job creation in our state
