GROWING STAMFORD'S ECONOMY

- Families of four who make \$50,000 annually will pay no state income taxes / Expanded state's income tax exemptions to residents making up to \$100,000
- Additional \$20 million** to support programs for new homeowners
- Regulated pharmaceutical prices** by making a statewide Drug Discount Card Program
- Secured healthcare benefits for workers who are terminated for striking or labor disputes
- Expanded state hiring programs** to increase employment and job creation
- Cut business taxes** to promote expansion of childcare facilities
- Created tax incentives for towns and businesses that build workforce housing
- Made licensing easier for nurses and physical therapists who move to CT

INVESTING IN STAMFORD'S EDUCATION

- Created a student loan forgiveness program to forgive up to \$20,000 in student loans per person in exchange for volunteering at a local nonprofit
- Secured \$164 million increase in new funding to local boards of education
- \$53.3 million in new funding for magnet schools
- Required high schoolers take a financial literacy class before graduating
- Received \$16 million to expand free school lunches
- \$9.3 million in new funding for charter schools



SUPPORTING VETERANS AND FIRST RESPONDERS

- Increased funding and benefits for firefighters who are diagnosed with cancer
- Expanded workers' comp coverage for anyone who experiences PTSD at work
- Streamlined licensing for nurses and physical therapists who move to CT
- Granted free graduate school tuition to veterans, their families, and members of the National Guard
- Increased support to municipal veterans programs

MAKING CT SAFER

- Restricted open carry for firearms
- Required safe storage and trigger locks for firearms
- Created electronic notifications for expiring gun permits
- Formed a special police task force to deal with abuse of kids online

FIGHTING FOR FAIRNESS IN CT

- Created the CT Voting Rights Act to strengthen anti-discrimination voting laws
- Enacted early voting In CT
- Protected healthcare providers who provide reproductive health care
- Required an English Language Learners Bill of Rights in schools
- Disqualified libraries that ban books from getting state grants
- Directed all state college and university campuses to provide reproductive health resources
- Ensured all state buildings have diaper changing tables
- Expanded assistance to refugees
