#### STANDING UP FOR CT CONSUMERS

- Required companies that charge you through an auto-renewal subscription to get your permission before charging you for the next billing cycle
- Insisted that companies that lease oil and fuel tanks remove them within 30 days after a customer cancellation
- Required mutual acknowledgement by a realtor and buyer when using an interpreter to close a sale and protect confidential information of any prospective buyer
- Protected precise geolocation data under our data privacy laws and created more stringent standards for targeted advertising to kids
