Dillon Secures Dollars for New Haven

School Construction an Issue

The state reimburses towns for the cost of local school construction, but sometimes in ways that seem arbitrary. Rather than reforming the system, they have adopted a "case by case" system of telling towns to seek waivers for specific projects. Such locally incurred school construction costs that are not reimbursed - or "ineligible" - are an ongoing issue that burdens our city budget, and New Haven property taxpayers, with debt.

This year, New Haven delegation members secured reimbursement for a total of \$74.3 million in "ineligible" costs. The sections I authored, totaling about \$11 million, sought costs denied for school projects that had been delayed by litigation since litigation was outside the control of the city.

Improving Health through the "Built Environment"

Our health and well-being are affected by the quality of life where we live and work. This year I successfully authored measures and worked with you on specific issues that directly affect our safety and health.

Traffic Calming for Westville Village Approved



The Bond Commission approved my request for dollars for traffic calming in Westville Village to improve walkability, safety, and access to local businesses.

Representative Dillon Hikes Dirt Bike Penalties

Alarmed at the dangers on our streets and the injury to a young constituent, I filed PA 13-154 to increase penalties for illegal use of dirt bikes on public roads. Governor Malloy signed the legislation in June, and in September the Board of Alders adopted stiffer penalties. Penalties are not the only tool - enforcement is key - but stiff penalties can make streets safer.

Genetically Modified Food

I cosponsored HB 6519 requiring labeling of genetically modified food, and supported the compromise (PA 13-183) which phases in a labeling requirement triggered by action in neighboring states.

Preventing Transmission of West Nile Virus in West River

Because the most recent Connecticut death from West Nile virus occurred in West River, and the mosquito population has been high for several years, I authored legislation to reduce West Nile virus there. It requires the commissioner of the Department of Energy and Environmental Protection with the Public Health commissioner and our local health department to

survey land for mosquitoes, enforce a ban on standing water, and encourage public outreach programs on standing water risks and West Nile virus symptoms. PA 13-19

Jobs and the Economy

Increase in Minimum Wage

I cosponsored PA 13-117, which increases the hourly minimum wage from \$8.25 to \$8.70 on January 1, 2014 and from \$8.70 to \$9 on January 1, 2015.

Glass Repair Bill

Representative Dillon and Jeanette When big insurance was steering glass repair work to its own subsidiaries at the expense of New Haven businesses, I filed legislation and

worked with New Haven delegation members to protect New Haven jobs.

The law provides assurances about your right to choose where to have repair work done. Big insurance is challenging the law in court. PA 13-57, effective January 1, 2014.

Apprenticeships for Youth

Our budget funded \$750,000 in new dollars to New Haven to be used for employment training and 'work-learn' internships for youth. The dollars will be distributed through a competitive process.

Shubert Bonding Approved

The arts have value, but also play a vital role in our local economy. With the 100th

anniversary of the Shubert I filed legislation for improvements. Reviving the Shubert was a key to reviving downtown; bookings rose at area hotels, and restaurants filled up. The Shubert also now works with the nearby Cooperative Arts Magnet. Although I got the ball rolling in committee, Governor Malloy's office took a hands on role, providing \$4 million on the Bond Commission.
