

# **CREATING EQUITY**

- Addressed age discrimination in the workplace limited the need for your age and other dates on job applications (PA 21-69)
- Joined seven states in making it illegal to discriminate based on hair texture and protective hairstyle (PA 21-2 "CROWN ACT")
- Modernized our breastfeeding laws and cut the sales tax on breastfeeding supplies (PA 21-27 and SB 1202)
- Declared racism a public health crisis and created a Commission on Racial Equity tasked with eliminating health disparities (PA 21-35)
- Prohibited insurance companies from charging more for victims of domestic violence (HB 6590)
- Created a new workforce pipeline program for individuals with disabilities (SA 21-10)
- Strengthened the rights of families who are not biologically related and for parents who have children through the assistance of donors (PA 21-15)



# **RESPONDING TO COVID-19**

- Cut unemployment insurance taxes on local businesses by excluding pandemic-related layoffs and paying directly into the fund (PA 21-5 & SB 1202)
- Ensured towns can continue to hold virtual meetings into 2022 and cut red tape to make outdoor dining a permanent option for our local bars and restaurants (SB 1202)
- Ensured access to virtual visits and monitoring for nursing home residents (PA 21-55) and created a statewide policy on visitation (21-71)
- Continued coverage for, and access to, telehealth (HB 6470 & PA 21-9)
- Increased funding to local health departments (SB 1202)

## **MAKING DEMOCRACY WORK FOR ALL**

- Voters will get to decide in 2022 if we should have early, inperson voting and in 2024 you'll decide if every registered voter in CT should be able to vote by absentee ballot (RA 21-1 and RA 21-2)
- Guaranteed two hours off from work to vote in state and • federal elections (SB 1202)
- Paved the way for permanent drop boxes for absentee ballots (SB 1202)
- Restored voting rights for individuals in community facilities or on parole (SB 1202)

### **SUPPORTING OUR FAMILIES**

 Fully funded free community college - meaning students can work on their associate degree without having to pay tuition out of pocket (SB 1202)

Provided more low-income families a break on their state income tax through the Earned Income Tax Credit (SB 1202) Strengthened domestic violence laws by allowing victims subject to coercive control by a family or household member to be eligible for civil restraining orders (PA 21-78) Eliminated state income taxes on IRA income over time, beginning in the 2023 tax year (SB 1202)

• Put community violence prevention programs on a path to sustainable funding and growth in our state - to serve more victims of gun violence and their families (PA 21-36) Raised awareness of child sex abuse (PA 21-64) and required comprehensive background checks for athletic leagues and youth camps (HB 6417)

Ensured our kids recover from this pandemic by requiring social emotional learning as part of professional development for teachers, expanding youth suicide prevention training, creating more outpatient services for kids, and ending lunch shaming when kids fall behind in paying for their school lunches (PA 21-46)
