SUPPORTING OUR SENIORS





As the co-chair of the Aging Committee, I fought for bills that prioritize transparency, accountability and support for the elderly population in Connecticut. On July 11th, Governor Lamont signed into law Aging Committee bills HB 6677 and HB 5781 at the Caring Connection Adult Day Center in Windsor. These bills bring transparency to nursing homes, move home care agencies from the Department of Consumer Protection to the Department of Public Health, add a Dementia Services Coordinator, protect seniors from involuntary discharge from a facility, lower the age for dementia services for adult day centers and

ELIMINATED MORE TAXES ON RETIREMENT

- Current law exempts 100% of pension and annuity income from the state's income tax, and we are halfway to phasing out 100% of IRA income for those making \$75,000 or less annually (\$100,000 for joint filers)
- We extended these exemptions to taxpayers making up to \$100,000 (\$150,000 for joint filers) by phasing-out the deduction between 2.5% and 100%, depending on your income
- For IRA deductions for the 2024 and 2025 tax years, the deduction percentage applies to the portion of income the law allows as a deduction, not to all IRA income



STANDING UP FOR CT CONSUMERS

- Required companies that charge you through an auto-renewal subscription to get your permission before charging you for the next billing cycle
- Restricted more types of telemarketing calls, texts and social media solicitations and limited the hours that telemarketing can take place
- Prohibited utility companies from passing off their lobbying and marketing expenses through rate hikes

SERVING THOSE WHO SERVED

- Granted free graduate school tuition to eligible veterans and their families, as well as active members of the National Guard
- Eased licensing requirements for childcare providers who serve military families
- Established funding and benefits for firefighters who are diagnosed with cancer

GROWING THE HEALTHCARE WORKFORCE

- Encouraging careers in our K-12 schools, offering nursing licenses at our colleges, and creating opportunities among our existing personal care attendant workforce
- Incentivizing licensed providers with 10 years experience to become adjunct faculty at CT colleges and universities
- Limiting the use of noncompete agreements for physicians, nurses and physician assistants
- Streamlining licensing for nurses and physical therapists who move to CT
- Partnering with other states for clinical training opportunities
