IMPROVING BICYCLE AND PEDESTRIAN ACCESS

- PA 09-154 | SB 735 EFFECTIVE: 07.01.09
- » Requires funding to be set-aside by the Department of Transportation
- » Enhances bicycle and pedestrian use in our neighborhoods
- » Increases funding to municipalities for bikeways and sidewalks with curb cuts or ramps
- » Establishes a board to create new policies and procedures that improve the bicycling and walking environment in Connecticut

"MOVE OVER" LAW

PA 09-121 | HB 5894 - EFFECTIVE: 10.01.09

» Establishes a new CT law regarding stationary emergency vehicles on travel lanes, breakdown lanes, or highway shoulders

- » Requires a motorist approaching stationary emergency vehicles to immediately slow down
- » Requires a motorist to move over one lane from the lane of an emergency vehicle, when safe and reasonable

Reforming Health Care System

Over 750,000 Connecticut residents went without health insurance at one point during 2007 or 2008. Health care costs everyone more each year and taxpayers pay more to supplement the people who do not have it. This year, Democrats took major steps towards reforming our broken health care system.

SUSTINET PLAN

CAPITOL **NEWS 2009**

Members of the General Assembly passed a compromise state budget that successfully closed an \$8.5 billion budget deficit for the next two fiscal years. I am pleased that we were able to make a compromise where important programs for some of the most vulnerable populations in our state were protected.

East Hartford will maintain its full fixed entitlement for education funding. In previous years, there was an adjustment that was negative for East Hartford. Now there will be no adjustment, which means an additional \$484,000 this year. This is something I have been working on with my colleagues for the past year. The budget successfully protects education by funding family resource centers, priority school districts, magnet and charter schools, local education aid, Head Start and

Providing for our Armed Forces Members & their Families

The service and sacrifices of our Armed Forces members must always be valued and honored. This session we passed several new laws to aid our armed forces and their families.

BEHAVIORAL HEALTH SERVICES

PA 09-10 | HB 6406 – EFFECTIVE: Upon passage

- » Ensures that members of the armed forces can receive transitional behavioral health services
- » Applies to families and dependents of armed forces members as well

RELIEF FOR MILITARY FAMILIES

PA 09-163 | HB 6394 – EFFECTIVE: Upon passage

- » Expands the Military Family Relief Fund
- » Allows immediate relatives of members not on active duty to receive benefits
- » Provides grants to pay for essential personal or household items when in hardship

SUPPORT FOR THE FAMILIES OF WOUNDED SOLDIERS

- PA 09-70 | SB 710 EFFECTIVE: Upon Passage
- » Expands the State Family and Medical Leave Act
- Permits employees to take up to 26 weeks of unpaid leave from work to care for injured family members who are military personnel

Assisting our Seniors

Improving the lives of seniors so they may be healthy, safe, and economically secure is a central role of our state government. To improve their overall quality of life, we passed several new legislative initiatives.

AFFORDABLE ELDERLY HOMECARE PA 09-64 | SB 814 - EFFECTIVE: 04.01.10

- » Expands access to affordable homecare support services
- » Helps seniors remain independent in their own homes rather than nursing homes
- » Expands personal care assistance services to more of our seniors

LOCATING MISSING SENIORS

PA 09-109 | SB 451 - EFFECTIVE: 07.01.09

- » Creates an emergency notification system similar to the Amber Alert, called the Silver Alert
- » Allows law enforcement agencies to issue public alerts for missing seniors

SENIOR DISCOUNT PROGRAMS

PA 09-53 | HB 5674 - EFFECTIVE: 10.01.09

- » Provides seniors greater access to senior citizen discount programs
- » Requires businesses to disclose details of programs and eligibility requirements

PATIENTS' RIGHTS AT A NURSING HOME

PA 09-168 | SB 455 - EFFECTIVE: 10.01.09

- » Expands the Nursing Home Bill of Rights to prohibit the solicitation of donations or gifts as a condition of admission
- » Extends protections to third parties, such as families and friends

Keeping our Children Safe & Healthy

East Hartford's children need our protection from harms. This legislative session I worked hard with my colleagues to pass legislation to help keep our children safe.

BANNING TOXIC CHEMICALS

PA 09-103 | HB 6572 - EFFECTIVE: 10.01.09

- » Bans bisphenol-A BPA, an industrial chemical with toxic properties
- » Baby bottles and food and beverage containers will be safer for kids

PREVENTING CARDIAC ARREST IN SCHOOLS

PA 09-94 | SB 981 - EFFECTIVE: 07.01.09

- » Requires each school to have an automatic external defibrillator AED
- » Provides training to school staff for AED use and also for CPR

GREEN CLEANING PRODUCTS

PA 09-81 | HB 6496 - EFFECTIVE: 10.01.09

- » Promotes use of safe green cleaning products
- » Hazardous cleaning chemicals currently used in most schools will be replaced
- » Requires schools to implement a green cleaning program



HEALTH INSURANCE FOR **AUTISM TREATMENTS**

PA 09-115 | SB 301 - EFFECTIVE: 01.01.10 Requires insurance coverage of critical treatments and benefits that will greatly help the lives of people with autism.

These treatments are:

- » The diagnosis to determine if an individual has an autism spectrum disorder
- » Behavioral therapies to children 14 years old or younger including, but not limited to, applied behavior analysis and cognitive behavioral therapy
- » Prescription drugs
- » Psychiatric and psychological services
- » Physical and occupational therapy
- » Speech and language pathology services

These results are:

- » Higher quality of life for the individual
- » Decrease in lifetime costs of treatment
- » Connecticut has become the 12TH state
- to require this comprehensive coverage

PROMPT TREATMENT OF ALLERGIES IN SCHOOLS

- PA 09-155 | SB 755 EFFECTIVE: 08.15.09 » Permits some students with asthma or allergies to carry inhalers and epi-pens in school » Allows students to self-administer with proper authorization » Adds licensed athletic trainers to the list of school personnel permitted to administer medication

- PA 09-209 | SB 948 EFFECTIVE: 07.01.09/10.01.09
- » Implements federal reforms
- » Creates many new safeguards against future mortgage foreclosures to better protect

» Regulates the mortgage lending process » Expands eligibility for state foreclosure

Government Efficiency

Making government functions more efficient is especially important during these difficult economic times. This year we took important steps to reduce the size of government and streamline some important functions.

PROBATE COURT REFORM

PA 09-182 | HB 6385 – EFFECTIVE: Upon Passage

- » Makes the probate court system sustainable for local caseload demands
- » Established a commission which consolidated courts and created new districts
- » Reduced the total number of probate courts from 117 to 54 statewide
- » Changes the current basis of compensating probate court judges, from fees the court collects to population and workload
- » East Hartford continues to remain its own probate court district
