CONTINUED FISCALLY RESPONSIBLE BUDGETING

- Historic funding for local schools: Prevented any town from receiving a funding cut to their local schools (\$6.5 million) and continued our commitment to funding local boards of education with an honest education cost sharing (ECS) formula (\$45 million)
- Supporting workers and small businesses: Protected workers whose health benefits are terminated by an employer following a strike or labor dispute; cut business taxes to promote expansion of childcare facilities
- Improving healthcare: Expanded pharmacy services to include vaccine administration of CDC immunizations, testing for COVID, flu, and HIV, and providing prescriptions for preventative HIV treatment
- Protecting reproductive health: Protected pharmacists and health care providers who are licensed in other states from discipline when they provide reproductive health services in our state

It is a privilege and honor to serve as your state representative. The 2023 legislative session is now in the rearview mirror, and I wanted to take a moment to check in and share some highlights from the past several months.

I'm proud to have worked on a budget that delivers historic tax cuts and increased funding for students, families, and our most vulnerable residents, while paying down our long-term debt, including an additional \$2.072 billion in unfunded future pension liability.

Most importantly, we did it by working together – without gimmicks or partisan politics. We prioritized education, supported non-profits, and invested in public safety without the fighting you see in Washington.

- Required companies that charge you through an autorenewal subscription to get your permission before charging you for the next billing cycle
- Prohibited utility companies from passing off their lobbying and marketing expenses through rate hikes
- Responded to inflation by freezing scheduled increases on the diesel tax - helping lower the cost of groceries and other commodities

- Current law exempts 100% of pension and annuity income from the state's income tax, and we are halfway to phasing out 100% of IRA income for those making \$75,000 or less annually (\$100,000 for joint filers).
- We extended these state income tax exemptions to taxpayers making up to \$100,000 (\$150,000 for joint filers) by phasing-out the deduction between 2.5% and 100% depending on your income.

BUILDING A SKILLED WORKFORCE

- Expanded school-based apprenticeship opportunities in aviation and aerospace, expanded training for future paraeducators, and dual credit/ enrollment opportunities
