NEUROMODULATION CENTER OF EXCELLENCE FOR VETERANS

Representative Genga was the proud sponsor of legislation establishing a \$2 million Neuromodulation Center of Excellence, which offers groundbreaking medical technology and life-changing care for disabled veterans.

TAKING PUBLIC SAFETY SERIOUSLY

- We expanded our “Fallen Officer Fund” to cover the families of firefighters, EMT personnel, and paramedics who are killed in the line of duty so that they can receive cash benefits and health insurance coverage.
- Increased penalties for street racing and takeovers, including two-year license suspensions.

- Increased state funding for local capital improvements related to special education.
