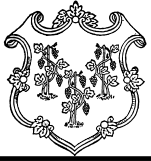

## RESOURCE CENTER OPENS

I am proud to report the opening of the new East Hartford Community Resource Center in the East Hartford Middle School at 777 Burnside Ave. The center will serve as a hub to provide local and state resources, referrals and support services to East Hartford residents. The goal of the center is to promote self-sufficiency – while respecting an individual’s culture, rights and dignity. Other goals include providing a welcoming center for residents.

Services that the new center will provide include: Interpreters for Spanish-speaking residents and speakers of other languages; assistance in resource research; school registration assistance; instruction for residents on Internet-based research; networking and referrals to other outside services; and English language speaking support.
