GROWING OUR ECONOMY

- · Paid family and medical leave went into effect this year
- We raised the minimum wage to \$14/hour starting July 1st of this year
- Expanded the debt-free community college (like Naugatuck Valley) program to more first-time, part-time students
- Established student loan reimbursement program for in demand health care and mental health workers
- Established the JobsCT program to help employers who meet job creation targets to earn rebates against insurance premiums and state taxes
- Expanded the successful Manufacturing Pipeline program

CUT YOUR TAXES

\$650 MILLION IN TAX RELIEF

- Increased the Property Tax Credit from \$200 to \$300
- Created a Child Tax Credit
- Cuts property taxes for retirees
- Ends income taxes on pension and annuity
- No gas tax through November
- Bus service, including HART, is free
- Lowered business tax rates for unemployment insurance



MAKING OUR NEIGHBORHOOD SAFER

- Funded task forces to address gun violence and auto thefts
- Toughened penalties for vehicle theft
- Stricter regulation of catalytic converter sales to cut theft
- Expanded hands-on training for our police officers
- Expanded the use of GPS monitoring
- Dealt with juvenile crime by investing in Youth Service Bureaus, work opportunities, and alternatives to incarceration
- Increased training and education of sexual abuse identification and prevention
- Made victims of domestic violence a protected class
- Addressed laboratory and case backlogs
- · Took steps to make online dating safer

PROTECTING OUR ENVIRONMENT

- Set a goal of reaching zero greenhouse gas emissions from electricity supplied to you by 2040
- Expanded financing to develop zero emission vehicle infrastructure, build more solar power and fuel cells, and reinforce our electric grid against the effects of climate change
- Expanded eligibility for participation in the state's brownfield remediation program to include companies who lease a property with an intent to own. This will expand our efforts to help cities and towns address their brownfields
- Created new incentives for consumer and commercial electric vehicles
- Exempted electric charging stations from property tax assessments
