# REDUCE YOUR MONTHLY ENERGY BILL

## EVERSOURCE PAYMENT PLANS AND ASSISTANCE

### Matching Payment Program

- Can lower a past-due balance with monthly payments as low as \$50 for electric or gas heating customers receiving public assistance benefits. For every dollar paid, customers receiving CEAP will get a dollar subtracted from the amount owed until the balance is paid off.

### Flexible Payment Program\*

- Available to all customers, regardless of income, to pay their past-due balance over a period of time. Residential customers with active service may be eligible for payment plans of up to 18 months.

### Connecticut Electric Discount Rate

- Only available for customers experiencing financial hardship

- Eversource is offering two types of discounts:
  - » **Receive a 10% discount**, if your household annual income for all adults over 18 is at or below 60% of the state median income, or you can show receipt of a public assistance benefit for at least one household member.
  - » **Receive a 50% discount**, if your household annual income for all adults over 18 is at or below 160% of the federal poverty guidelines, or you can show receipt of public assistance for at least one household member.

## HOW TO SWITCH TO A THIRD-PARTY SUPPLIER:

1. Go to [EnergizeCT.com](https://energizect.com)
2. Click Rate Board.
3. Click Compare Energy Supplier Rates.
4. Narrow your search by filling out information regarding your electric bill.
5. Once information is entered, you can compare different rates.
6. Click “View offer details” to read fine print for the rate offered.
7. Once you choose a third-party supplier, click “enroll now” which will allow you to enroll on the company website.
