EDUCATION & EARLY CHILDHOOD INITIATIVES

- Doubled grants awarded to school districts for bilingual education

- Increased funding for infant and toddler care programs, increased pay to childcare workers and approved a state child tax payment
- Provided grants to local schools to hire more support staff, with emphasis on mental health: social workers, psychologists, and counselors
