

An Act Concerning Child Identity Theft

Identity theft occurs when an individual's identity is used by another person for the imposter's personal gain. Unfortunately, this type of theft is happening more frequently, resulting in hundreds of thousands of stolen identities throughout the country each year. Under current law, combining someone's social security number with an unrelated name is not considered a crime, a loophole that has major implications for children, whose social security numbers are at particular risk. This bill closes a loophole in the state's current identity theft law by deleting the requirement that the perpetrator must use or attempt to use the person's name for the action to constitute a crime. This will reduce the use of children's social security numbers for the purposes of identity theft.

Energy Reform

Like you, I've reduced my electricity use, but it's still too costly. The electric market deregulation enacted years ago hasn't worked, so this year we passed a major act to help alleviate the burden on customers. This legislation would reduce energy costs by:

- » Investing in energy efficiency and clean energy technologies in both homes and businesses
- » Reforming state agencies to provide tighter controls over your energy costs
- » Achieving long-term savings for all electric customers

Development Incentives

Governor Malloy has signed the "First Five" legislation that provides incentives for up to five business development projects that commit to creating at least 200 new jobs each. We will continue to work with Governor Malloy to utilize bonding for infrastructure improvement projects that will create jobs.

Better Health Care Access & Affordability

Health care benefits are one of the largest expenses faced by individuals and employers. We combined two major health care reforms that protect and increase access to quality, affordable health care.

The Connecticut Health Care Partnership offers the state health insurance coverage to municipalities and to non-profit organizations. Taking advantage of the increased bargaining power and reduced administrative costs associated with the state plan will allow municipalities and non-profits to provide quality care with less cost. When municipalities save money on health care, those savings are passed down to property taxpayers.

In addition, better health care delivery will be attained for individuals and groups through a comprehensive plan that lays out a framework for a state-wide health care delivery system that also leverages the state health plan pool to contain costs and promote preventive care.

Eliminating Toxic BPA

I have supported important legislation that would limit our exposures to Bisphenol-A (BPA), which is known to have negative health-related side effects. A new law prohibits the manufacture, sale, offering for sale, or distribution of thermal receipt or cash register receipt paper containing BPA in Connecticut. We have already banned the chemical BPA from infant formula and baby food containers. BPA exposure can be linked to various illnesses and ailments including: prostate cancer, breast cancer, obesity, attention deficit disorder, hyperactivity disorder, disruption in reproduction and fertility (including damage to fetus).
