OUR BIPARTISAN BUDGET INCLUDES

PROTECTING TAX CUTS

WE PASSED A BIPARTISAN BIENNIAL BUDGET THAT INCLUDES HISTORIC TAX CUTS AND INVESTMENTS FOR OUR COMMUNITY.

- LARGEST INCOME TAX CUT in state history
- Biggest investment in public education ever
- Expansion of debt free community college
- Protected safety net programs
- New supports for Intellectually and Developmentally Disabled Community
- Increased Earned Income Tax Credits for Working Families
- Expended cuts to retirement savings

THIS SESSION WE PROTECTED THESE TAX CUTS AND INVESTED MILLIONS OF FEDERAL FUNDS IN:

- Higher Education \$160 million, growing to \$200 million
- Childcare \$21.8 million
- Mental Health \$24 million
- Nonprofits \$50 million

INVESTING IN OUR COMMUNITIES

Some of this year's local investments include:

- Close to \$200 million in education funding for Bridgeport Public Schools
- \$3 million in remediation funds to support a Fairfield housing project
- \$8 million to support bringing professional soccer to Bridgeport
- \$2 million for electric buses in Fairfield
- \$22.5 million of CIF Funds to demolish and abate the PSEG coal plant in Bridgeport
- \$255,000 in Recreational Trails Grant Funding for the Villa Ave Open Space Trail









LEADING THE PUBLIC HEALTH COMMITTEE

In my second year as Co-Chair of the Public Health Committee, I have continued to lead the work to help our families, neighbors, and communities access healthcare. This year we:

- Made telehealth expansion a permanent option for accessing healthcare (PA 24-110)
- Required medical offices to provide accessible equipment for those with disabilities (PA 24-113)
- Increased access to food and nutrition programs for children (PA 24-82)
- Improved data collection and monitoring of non-fatal opioid overdoses (PA 24-120)
- Addressed healthcare workforce shortages with nursing and social work compacts (PA 24-83 & PA 24-30)
- Improved safety conditions for the in-home healthcare workforce (PA 24-19)
- Expanded paid sick leave to include many more private sector employees (PA 24-8)
- Required pediatricians and primary care providers to give patients educational materials on gun safety and safe storage (PA 24-19)



HOUSING

The cost of housing remains a tremendous burden on both families and businesses working to recruit their workforce. This session we:

- Incentivized towns to develop more multi-family housing (PA 24-143)
- Required 45-day notice of rent increases (PA 24-110)
- Streamlined the process for converting vacant nursing homes into housing (PA 24-143)
- Prioritized the use of surplus state owned land for affordable housing (PA 24-143)
- Increased the value of state rental vouchers (PA 24-143)





ELECTION INTEGRITY

Some of the steps, we took in PA 24-148 to provide both safeguards to election integrity and consequences for illegal actions include:

- Extended the statute of limitations for election-related crimes
- Required video recording of absentee ballot drop boxes
- Recording and reporting of how absentee ballots are received
- Required a log of who has requested applications, their address, and number of applications requested
- Limited the number of absentee ballot applications a person may request 90 days or more before an election
- Established specific criminal penalties for harassing poll workers
