VETERANS

Building off our 2024 law, we granted towns some new options to expand property tax exemptions for veterans and Gold Star families, to include:

- Gold Star spouses, veterans rated Totally Disabled due to Individual Unemployability (TDIU), and veterans impacted before 2024.
- Up to two acres of land.
- A cap on the exemption at the municipal median property value as a means of expanding eligibility in a fiscally sustainable way.

CARING FOR THE ENVIRONMENT IS CARING FOR OURSELVES

- Regulated the use of rodenticides.
- Established an extended producer responsibility program around the collection and recycling of batteries. This will reduce soil and water contamination, minimize landfill waste, and prevent batteries from exploding in waste management facilities.
- Set new state climate goals for greenhouse gas reduction.
- Supported clean energy jobs through tax incentives.

WORKERS

FISCAL RESPONSIBILITY AMID WASHINGTON CHAOS

The Trump Administration cut funding to disabled veterans, stripped healthcare from children, and rolled back access to programs for our families. To make matters worse, we are forced to deal with significantly downgraded revenue forecasts driven by growing instability and shaky consumer confidence thanks to the federal government.

To address these issues, this year we:

- Established an investable trust to provide sustainable funding for new childcare programs.
- Provided historic new funding for special education.
- Improved access to quality health care and community nonprofit providers.
- Established an Enhanced Tax Credit for Families: For the first time, we've created a refundable tax credit of \$250 per filer through the Earned Income Tax Credit (EITC) framework—helping working families keep more of what they earn.
- Supported Childcare Providers: We created a \$500 refundable tax credit for home daycare owners—recognizing and sustaining the vital care workforce that allows families to work.

RESIDENTIAL HEAT PUMP SYSTEMS PLAN

This past session, the legislature enacted a law requiring the DEEP commissioner to develop a plan for installing efficient heat pumps for affordable heating and cooling systems in the state. We included \$25 million for these heat pumps to reduce energy costs for vulnerable populations statewide.
