- The CDC and Governor Lamont are continuing to require individuals to wear masks in public when you are unable to "social distance" more than 6 feet away from others.
- If you are out of work, you have the right to file for unemployment insurance. Visit www.FileCTUI.com to file your claim or call: 860-263-6975, 203-455-2653, 860-263-6974 or 203-455-2650.
- If you are a business owner, the Department of Economic and Community Development is developing and updating guidelines on safe ways to operate your business: business.ct.gov/Recovery. They have also opened a small business hotline: 860-500-2333.
- If you notice a business not operating in a safe manner, call 2-1-1.

In addition, we have worked with the federal delegation and the Governor's office to develop and fund a number of smaller assistance programs ranging from funding for artists to farmers, to helping our schools deal with unexpected expenditures and assisting small businesses. I know that working with state agencies and our partners during this time can be complicated. Phone lines are crowded, and applications may be confusing. My office is here to help. Call or email me anytime, and I promise I will get you help.

ADVOCATING FOR YOU DURING THIS TIME

This has been a remarkably challenging time for all of us. My office has worked with many of you to fix issues including unemployment applications, helping your businesses apply for financial aid, and working with the DMV to get your cars registered. I know that it is during these challenging times when we need government help and services the most.

That's why I have worked with my colleagues to advocate for all of you with the Governor and his administration. I am proud to say that because of our advocacy, we have expanded tele-medicine, brought additional COVID-19 testing sites to our community, expanded affordable childcare options for front-line workers, and delayed due dates for state income taxes and municipal property taxes. If there are more ways that we can make state government work better for you, please let me know.

THE BOND PACKAGE

One of the few votes we took this year in the House of Representatives was for the Bond Act. I am proud to say that this legislation contained authorizations for state aid for our community. The bill also contained funds for workforce development, launching the Paid Family Medical Leave insurance program and funding transportation improvements for the Mixmaster through Waterbury. As a Member of the Finance, Revenue and Bonding Committee, I was able to secure an additional \$1 million for Municipal Projects for the City of Waterbury (HB 5518).

As a member of the Veterans Affairs Committee, I was part of the decision to induct four Waterbury based servicemen into the Connecticut Veterans Hall of Fame: Robert Cahill Sr., Alfred Comeau, John Sarlo and Jack Shea. I'm grateful for the years of service these men have given to their country and neighbors in Waterbury.

ON THIS SUMMER'S SPECIAL SESSION

In early June, legislative leadership and the Governor agreed that it was time for members of the General Assembly to meet and pass reforms in response to the current crises our state faces. In addition to ensuring that our residents have the resources to avoid the COVID-19 virus and are adequately supported to cope with social distancing, we intend to ensure that everyone has access to absentee ballots in the November general election. We also intend to take immediate action on police accountability and transparency legislation. I was one of the few legislators who was in attendance for 100% of the votes taken during my first term in the General Assembly, and I will continue that commitment to you through these momentous votes.

WHERE DO WE GO FROM HERE?

While we continue to be guided by public health experts on the steps we need to take to safely "reopen", we also have an opportunity to build a stronger and more robust state.

Already we are working to ensure hospitals and health care providers such as nursing homes have adequate stock of personal protective equipment. And we are working with farmers and food banks to protect and localize our food supply chain.
