SENIOR UPDATE

PROPERTY TAX RELIEF EXPANDED

HB 6458, An Act Lowering the Age of Eligibility for Property Tax Relief for Senior Citizens and Establishing a Task Force to Protect Senior Citizens from Fraud, gives towns the ability to lower the age to 65 to provide property tax relief for seniors and as described, creates a task force to prevent fraud targeted at seniors.

PHASING OUT THE INCOME TAX ON PENSIONS AND ANNUITIES

HB 6689, An Act Concerning the State Budget, continues to phase out the state income tax on pensions and annuities - exempting an additional 28% over the next 2 years, which will exempt in total 70% of this income from state taxes for most seniors.


BANNING AGE DISCRIMINATION

SB 56, An Act Deterring Age Discrimination in Employment Applications, prohibits age discrimination during the employment application process.

NURSING HOME RIGHTS

HB 6457, An Act Concerning Access to Recordings and Images from Technology Used by Nursing Home Residents for Virtual Visitation and Virtual Monitoring, expands the rights of nursing home residents and ensures they can use technology to facilitate virtual visits with family and friends.

RENTERS' REBATE

Based on legislation I introduced with Senator Looney we exempted seniors and the disabled from the burdensome yearly landlord verification requirement if they previously verified an address. This requirement also can't delay submission of an application for the renters' rebate program and still allows for extensions for medical reasons.
