Energy Assistance

- ▶ **Private Fuel Banks** - Many towns have private fuel banks that provide winter energy assistance to local residents who do not qualify for other programs. For more information, call 2-1-1 Infoline and ask for the location of the fuel bank nearest you.
- ▶ **Utility Arrearage Forgiveness Programs** - Most of Connecticut's gas and electric utility companies offer assistance programs that can help customers pay a portion of their back utility bills. Contact your utility company or your local community action agency at (203) 352-4846.
- ▶ **Weatherization Assistance Program** - You may be eligible for free assistance in weatherizing your home or apartment. Measures may include installing storm windows, insulation of your attic and/or walls, and servicing of your heating system. Call 1-800-842-1132 for additional information.
- ▶ **Winter Protection Program** - Participants in this program will be coded by their utility companies as "hardship cases" and will not have their utility service shut off between November 1 and April 15 of each year. For more information, contact your utility companies.
- ▶ **Connecticut Energy Assistance Program** and the **Contingency Heating Assistance Program** - These programs are for residents who may need help with the costs of home heating bills and energy use. For further information and referral to an application site in Norwalk call 2-1-1.

Energy Efficiency

The state offers programs and specialized loans to help citizens improve the energy efficiency of everything from light bulbs to heaters and insulation remodeling. One program that offers discounted products can be found at:

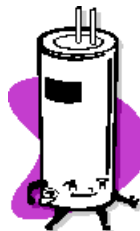

Energy Product Tax Holiday

You can also take advantage of the Energy Product Tax Holiday and pay no sales tax on approved purchases. This tax incentive lasts until June 30, 2007 and applies to the following items:

- Programmable thermostats
- Window film
- Caulking
- Window and door weather strips
- Insulation
- Water heater blankets
- Water heaters
- Ground-based heat pumps
- Oil furnaces that are not less than 85% efficient

These other items are also exempted if they meet the Energy Star standard:



- Boilers
- Natural gas furnaces
- Propane furnaces
- Windows
- Doors

Making Your Voice Heard

If there is a specific issue or legislation that you would like to advocate for or against, one place where you can do this most effectively is in a public hearing. Our committees often have public hearings where you can speak out and deliver testimony to the committee members. One person's testimony can make the difference on how a proposed bill is viewed.

Most public hearings are held in the Legislative Office Building in Hartford. For information on when the hearings take place, please visit www.cga.ct.gov and read the Bulletin or click on a particular committee's link. Make sure that the bill that you wish to speak about is on the committee's agenda for that day.



If you decide to come testify, remember to bring copies of your prepared remarks for committee members to read. You must sign up to speak at the hearing, and sign-ups usually start one hour before the hearing begins.

I am confident you will find the process interesting, and you will gain insight into the importance of citizen involvement.
