# ACCESS HEALTH CT FAQs FOR 2015

## **CAN ANYONE USE ACCESS HEALTH CT?**

While not everyone will qualify for discounted coverage, almost anyone can use the health insurance marketplace to find and enroll in a plan. If you do not have health insurance in 2015, you may have to pay a fee when you file your tax returns.

## **HOW DO I SIGN UP?**

In addition to calling and going online, you may also visit your local enrollment center for face to face guidance:

## **MUST I PURCHASE HEALTH INSURANCE THROUGH ACCESS HEALTH CT?**

No, you do not have to purchase health insurance through the marketplace, but it is the only way to qualify for a federal discount.

## **WHAT ARE MY PLAN OPTIONS?**

Access Health CT offers individual insurance policies sold by Anthem, ConnectiCare, HealthyCT and UnitedHealthcare, as well as, the state's HUSKY Health Program.

People with incomes below 400 percent of the poverty level (\$46,680 for an individual or \$95,400 for a family of four) may get a discount on their premiums if they buy coverage through Access Health CT. The discount is actually a federal tax credit that reduces the cost of the premium. Individuals with very low incomes may qualify for the state's HUSKY health insurance program.

## **WHEN IS THE DEADLINE TO ENROLL?**

If you want your coverage to begin on January 1<sup>st</sup>, you must purchase it by December 15<sup>th</sup>. You can purchase insurance any time until February 15<sup>th</sup> but it will not take effect until February 1<sup>st</sup> at the earliest.

If you miss the February 15<sup>th</sup> deadline, you will only be able to enroll if you qualify for HUSKY or experience a qualifying event (such as losing your job, getting married, or the birth of a child).
