## **CAPITOL UPDATE 2024**



#### DELIVERING FOR SOUTHINGTON

- Rescued the Southington Library Project with a **\$5 million** state award to improve the building's size and exterior look.
- Secured over **\$1 million** in state and federal funding for the YMCA to finish dredging Sloper Pond, as well as expand the day camp's office and infirmary.
- Delivered **\$99,700** for the Calendar House Senior Center to fund their outdoor fitness initiative and other improvements.





#### WINS FOR OUR COMMUNITY

- \$500,000 to rehabilitate the Southington High School track
- **\$21,600** for Rogers Orchards to construct a tap room and community hub
- **\$20,000** for the ARC of Southington to provide residents assistive technology and furnishings
- **\$7,270** open space grant from Connecticut Recreational Trails
- **\$5,000** for upkeep at the Merriman Cemetery
- \$4,220 for the Southington Community Cultural Arts



## COMMITTED TO PUBLIC SAFETY

- Approved funds to establish two new juvenile residential treatment centers, in an effort to address juvenile crime by reducing occurrences of catch and release.

- Authorized municipalities to combat noise pollution over 80 decibels and send fines directly to violators.
- Supported police on traffic stops that often help to uncover serious crimes, such as the possession of illegal weapons and drugs.
