EXPANDING VOTING RIGHTS

- Voters will get to decide in November 2022 at referendum if we should have early, in-person voting
- In November 2024, voters will decide by referendum if every registered voter in CT should be able to vote by absentee ballot
- Ended prison gerrymandering the practice of counting individuals where they are incarcerated instead of where they are from

ELIMINATING WELFARE LIENS

- Eliminated most "welfare liens" to bring Connecticut in line with 48 other states
- This policy will remove a roadblock to upward mobility and home-ownership for those in our most vulnerable communities.



PUTTING FAMILIES FIRST

- Provided funding for legal representation for tenants facing eviction
- Fully funded free community college meaning students can work on their associate degree without having to pay tuition out of pocket
- Eliminated state income taxes on IRA income

A GREENER CT

- Regulated the harmful chemical "PFAS"
- Provided more money to towns and redemption centers to ensure these products don't wind up as litter or in a landfill
- Created a competitive program for fuel cell projects that favors Connecticut-made equipment and the redevelopment of brownfields and landfills
