BANNING TOXIC CHEMICALS

- PA 09-103 | HB 6572 EFFECTIVE: 10.01.09
- » Bans bisphenol-A (BPA), an industrial chemical with toxic properties
- » Baby bottles and food and beverage containers will be safer for kids

NEW SAFEGUARDS AGAINST SEX OFFENDERS

PA 09-199 | SB 533 - EFFECTIVE: 09.01.09

» Requires the Dept. of Public Safety to notify the superintendents of schools in communities where sex offenders live or plan to live

REQUIRING CYSTIC FIBROSIS SCREENINGS

PA 09-20 | HB 6263 - EFFECTIVE: 10.01.09

- » Promotes early detection of cystic fibrosis
- » Requires all hospitals to test for cystic fibrosis in infants
- » Early treatment can improve health, longevity, and quality of life

PROMPT TREATMENT OF ALLERGIES IN SCHOOLS

PA 09-155 | SB 755 - EFFECTIVE: 08.15.09

- » Permits some students with asthma or allergies to carry inhalers and epi-pens in school
- » Allows students to self-administer with proper authorization
- » Adds licensed athletic trainers to the list of school personnel permitted to administer medication

GREEN CLEANING PRODUCTS

PA 09-81 | HB 6496 - EFFECTIVE: 10.01.09

- » Promotes use of safe green cleaning products
- » Hazardous cleaning chemicals currently used in most schools will be replaced
- » Requires schools to implement a green cleaning program.

PROTECTING STUDENT-ATHLETES

PA 09-94 | SB 981 - EFFECTIVE: 07.01.09

- » Requires each school to have an automatic external defibrillator (AED)
- » Provides training to school staff for AED use and for CPR

GOVERNMENT EFFICIENCY THROUGH REGIONALISM

As a member of the Planning and Development Committee, I had the opportunity to discuss "Smart Growth" initiatives which encourages regional cooperation among municipalities, maximizing resources, limiting waste, and planning for the future.

**IMPROVING REGIONAL COOPERATION

PA 09-231 | HB 6585 - EFFECTIVE: 07.01.11

- » Allows regions to enter into mutual agreements to promote regional economic development
- » Allows regions to share property tax revenue from the new developments
- » Allows municipalities with approved regional agreements to share part of the sales and use tax

**SMART GROWTH AND CONSERVATION

PA 09-230 | HB 6467 – EFFECTIVE: 07.01.10

- » Helps preserve open space through conservation planning
- » Requires the state, regions, and municipalities to prepare periodic plans for balancing the need to develop land

PUBLIC SAFETY

Keeping the public safe and secure in our neighborhoods and on our streets is one of the key functions of government. This session, we made several advancements to protecting the public.

INTERSECTION SAFETY

PA 09-171 | SB 966 - EFFECTIVE: 10.01.09

- » Allows cities and towns to adopt "blocking the box" rules
- » Prohibits cars and trucks from going through certain intersections if doing so blocks other vehicles from being able to cross the intersection

ILLEGAL STREET RACING **ENFORCEMENT**

- PA 09-120 | HB 5262 EFFECTIVE: 07.01.09
- » Creates new penalties for illegal street racing
- » Requires that the vehicle used for racing be impounded for 30 days
- » Increases fines for anyone racing a vehicle not registered to them
 - up to \$2,000 for the first offense
 - up to \$3,000 for any others

****IMPROVING BICYCLE AND** PEDESTRIAN ACCESS

- PA 09-154 | SB 735 EFFECTIVE: 07.01.09
- » Requires path funding to be set-aside by the Department of Transportation
- » Enhances bicycle and pedestrian use in our neighborhoods
- » Increases funding to municipalities for bikeways and sidewalks with curb cuts or ramps
- » Establishes a board to create new policies and procedures that improve the bicycling and walking environment in Connecticut

PROTECTING YOUR FAMILY, HOME, AND CREDIT

Foreclosures and Neighborhood Protection

The national foreclosure crisis has put many Connecticut families at risk of losing their homes. This year, House Democrats created safeguards around mortgage foreclosure, mortgage lending, and neighborhood preservation.

FORECLOSURE PROTECTION

PA 09-209 | SB 948 - EFFECTIVE: 07.01.09

- » Implements federal reforms
- » Improves how lending professionals are licensed
- » Expands eligibility for state foreclosure prevention programs
- » Makes the state's foreclosure mediation program mandatory

PROTECTING COLLEGE STUDENTS CREDIT

- PA 09-167 | HB 6483 EFFECTIVE: 07.01.09 » Requires the Board of Governors of Higher Education to adopt policies » Regulates credit card marketing practices on public college campuses » Protects young consumers from being unfairly targeted

EMERGENCY MORTGAGE ASSISTANCE

- » Expands eligibility for the Emergency Mortgage Assistance Program

PREVENTING BLIGHT

- foreclosure crisis
- » Provides maintenance to improve vacant foreclosed properties
- » Allows municipalities to enforce the requirement to repair or maintain vacant
- real estate using current laws

Improving the lives of seniors so they may be healthy, safe, and economically secure is a central role of our state government. To improve their overall quality of life, we passed several new legislative initiatives.

AFFORDABLE ELDERLY HOMECARE

PA 09-64 | SB 814 - EFFECTIVE: 04.01.10

- » Expands access to affordable homecare support services
- » Helps seniors remain independent in their own homes rather than nursing homes
- » Expands personal care assistance services to more of our seniors

DISCOUNT PROGRAMS FOR SENIORS

PA 09-53 | HB 5674 - EFFECTIVE: 10.01.09

- » Provides seniors with greater access to senior citizen discount programs
- » Requires businesses to disclose details of programs and eligibility requirements

**PATIENTS RIGHTS AT A NURSING HOME

PA 09-168 | SB 455 - EFFECTIVE: 10.01.09

- » Expands the Nursing Home Bill of Rights to prohibit the solicitation of donations or gifts as a condition of admission
- » Extends protections to third parties, such as families and friends
