#### **IMPROVING HEALTHCARE IN OUR STATE**

- Allowed over-the-counter drugs (including lifesaving opioid antagonists) to be sold through regulated vending machines
- Expanded pharmacy services to include vaccine administration of CDC immunizations, testing for COVID, flu, and HIV. Created temporary mobile pharmacies and required pharmacies to have a plan for unscheduled closings, including a method of notifying customers and using pickup lockers
- Established the Office of the Behavioral Health Advocate to help providers and patients navigate our insurance system, and expanded workers' comp coverage for anyone who experiences PTSD at work
- Created a statewide Drug Discount Card Program, regulated pharmaceutical sales reps, and banned anticompetitive loopholes in healthcare contracts

# MAJOR INITIATIVES AFFECTING LEDYARD, MONTVILLE, AND NORWICH

#### MAKING CONNECTICUT SAFER

- Required bright orange labels on prescription opiates, and required trained EMTs to carry and use EpiPens
- Responded to wrong way driving by installing at least 120 wrong way driving systems on our highway exit ramps and testing directional rumble strips to alert drivers that they are driving in the wrong direction
- Responded to Opioid Addiction: created a harm reduction pilot to prevent overdoses - under the care of licensed providers; established a dedicated funding source for the bulk purchase of Narcan

#### **SUPPORTING WORKERS AND SMALL BUSINESSES**

- Required full disclosure of hidden fees on small business loans and required any loan offers to be good for at least three days
  - Cut the number of reporting requirements for businesses, cut business taxes to promote expansion of childcare facilities, and made it easier for small contractors to bid on state projects
- Protected workers whose health benefits are terminated by an employer following a strike or labor dispute
- Expanded JobsCT to increase employment and job creation in our state
- Created tax credits and incentives for towns and businesses that build workforce housing.

#### **BUILDING A SKILLED WORKFORCE**

- Encouraging careers in our K-12 schools, offering nursing licenses at our colleges, and creating opportunities among our existing personal care attendant workforce, and incentivizing licensed providers with 10 years' experience to become adjunct faculty at CT colleges and universities
- Limiting the use of noncompete agreements for physicians, nurses, and physician assistants, and streamlined licensing for nurses and physical therapists who move to CT
- Partnering with other states for clinical training opportunities

#### SUPPORTING SENIORS

- Current law exempts 100% of pension and annuity income from the state's income tax, and we are halfway to phasing out 100% of IRA income for those making \$75,000 or less annually (\$100,000 for joint filers); we also extended these exemptions to taxpayers making up to \$100,000 (\$150,000 for joint filers) by phasing-out the deduction between 2.5% and 100%, depending on income
- We expanded Medicaid coverage for services
- Expanded eligibility for seniors to participate in adult day services, increased funding for elderly nutrition and Meals on Wheels, and we allowed banks to freeze transactions when they suspect a senior is being scammed
