## OTHER IMPORTANT LEGISLATION:

- **SUPPORTING BARBERS AND HAIRDRESSERS:** Individuals will now be able to acquire a barber, hairdresser or cosmetician license without having to submit to a state or national criminal background check, and the Department of Public Health is now prohibited from denying a license to an individual with a felony. Individuals will now have a second chance to obtain a job without having to be penalized for their past. **(PA 17-112)**
- **RENTERS REBATE:** An unfortunate change that came with the state budget was transferring the administration of the Renters’ Rebate program to the towns, which had resulted in a delay of renter’s rebate checks going out this year to the many seniors and those eligible who rely upon it. The good news is that after we spoke to our legislative leadership we were able to pass legislation to fix and restore the program. Renters should see no difference and those who have already applied can expect to see checks in December.
- **CHILD CARE FOR WORKING FAMILIES:** With the State budget that passed we were able to restore funding to the Care 4 Kids child care subsidy program. This funding will allow for the program to reopen enrollment and begin to address the 5,769 families who have been on the waiting list. This is a program that helps low-income families afford safe, quality child care and allows parents to remain in the workforce.
- **AFFORDABLE HIGHER EDUCATION:** Making college more affordable is one of our top priorities. With the state budget we restored over \$50 million to the University of Connecticut from a Republican budget that would have led to dramatic tuition rate increases and cuts to our flagship university. In addition we took two important steps aimed at lowering the cost of attending our state’s public colleges and universities by cutting red tape - making it easier for schools to secure goods and services while still requiring strong oversight policies. Also, we required state schools to establish guidelines to minimize student costs and cut down on textbook costs. **(PA 17-130)**
- **TRANSPORTATION LOCKBOX:** We also passed a resolution that, if approved by voters in the next election, will ensure money deposited into the Special Transportation Fund can only be spent on transportation. **(HJ 100)**

## WOMEN'S RIGHTS

No longer will a business be able to deny women employment opportunities because of pregnancy, or retaliate when reasonable accommodations are requested. **PA 17-118** strengthens current protections for pregnant and nursing women, requires employers to make reasonable accommodations for these employees, and sets up protections that prevent an employer from discriminating against pregnant women. These protections are critical to women's financial security and are good for families and the economy.

## DERECHOS DE MUJERES

Ya nunca más un negocio podrá negarles oportunidad de empleo a mujeres por estar embarazadas, o tomar represalias cuando se solicita algún acomodo razonable. **PA 17-118** refuerza las leyes existentes para mujeres embarazadas o que estén lactando, requiere que empleadores provean acomodaciones razonables para estas empleadas, y establece protecciones que impiden a empleadores discriminar en contra de mujeres embarazadas. Estas protecciones son valiosas para la economía, la seguridad financiera de las mujeres y para el bienestar de sus familias.

## REFORMING THE BAIL SYSTEM

Under our current system of pretrial detention, low-risk offenders are routinely held in jail simply because they cannot afford bail. Under new legislation, judges are barred from requiring cash-only bail and can no longer require bail for minor crimes unless that person poses an immediate threat or is being held for a family violence crime. **(PA 17-145)**

## SOCIAL SECURITY TAX EXEMPTION FOR SENIORS

The budget we passed includes a provision that will exempt social security and pensions from the state income tax starting in 2019. This will help provide much needed tax relief to those who need it most and allow them to keep more of their own money. Another law requires landlords to return any security deposit that exceeds one month's rent if the tenant turned age 62 after paying the deposit, upon request of the tenant. **(PA 17-236)**

## REFORMA DEL SISTEMA DE FIANZAS

Bajo nuestro sistema judicial actual de detención pre-juicio, los ofensores de bajo riesgo se quedan rutinariamente en la cárcel por no poder pagar fianza. Con esta ley, será prohibido que un juez requiera que la fianza se pague con dinero en efectivo solamente y tampoco puede fijar fianzas por delitos menores a no ser que el juez determine que esa persona posee peligro inmediato o que haya sido detenido por un crimen de violencia familiar. **(PA 17-145)**

## EXCLUSIÓN DEL IMPUESTO DE SEGURO SOCIAL PARA ADULTOS

El presupuesto que aprobamos incluye una provisión que exime el impuesto estatal sobre ingresos de seguro social y pensiones a partir del 2019. Esto ayudara a proveer alivio de impuestos a aquellas personas que más lo necesitan y los ayudara a mantener más de su propio dinero. Otra ley requiere que los dueños de propiedades devuelvan cualquier depósito de seguridad de arrendamiento que sobrepase un mes de renta si el inquilino cumple 62 años de edad luego de pagar el depósito, cuando el inquilino lo solicite. **(PA 17-236)**

## REMOVING HEALTHCARE BARRIERS

The cost of prescription drugs places a large burden on many of us, especially those living on a fixed income. **PA 17-241** removes barriers at pharmacies that have prevented some patients from being able to receive a cheaper generic medication, and also increases transparency in prescription drug pricing for the benefit of the patient.

## ELIMINANDO BARRERAS DE CUIDADO MEDICO

El costo de recetas médicas es una carga grande para muchos de nosotros, especialmente los que viven de una entrada fija. **PA 17-241** elimina la barrera que ha hecho difícil que pacientes reciban medicinas genéricas más económicas en las farmacias, y aumenta la transparencia en los precios de recetas para el beneficio del paciente.
