PUTTING WORKING AND MIDDLE-CLASS FAMILIES FIRST

- Provided new health care coverage to 40,000 low-income residents and families (SB 1202) [regardless of immigration status (HB 6687)]
- House Democrats fought for voter registration and unbiased voter info for public housing tenants (HB 6408)

- Expanded workers' comp benefits for PTSD to cover emergency responders, corrections workers, dispatchers and front-line health care providers who were on the front lines of the COVID-19 pandemic (SB 660)
