SUPPORTING AND HONORING VETERANS

- We excluded veterans' pension benefits from income eligibility determinations under HUSKY A & D, Medicaid, Medicare Savings Program, and CEAP.
 Additionally, we exempted service-connected disability compensation from income calculations for public defender eligibility - expanding access to legal defense for veterans with mental health conditions.
- We improved access to funds and job creation for our veterans by prioritizing disabled veteran entrepreneurs in the Small Business Express loan program.
- We provided no-cost driver's license renewals for veterans, and required the DMV to issue vouchers for veterans whose licenses are close to their expiration dates.

 Program to cover non-certified school employees, such as secretaries,
 nurses, custodians, security officers, and paraeducators.
- Expanded the program formerly known as MyCTSavings by including Personal Care Attendants (PCA's), allowing workers in a notoriously low-paying industry to have access to a state-administered retirement plan utilizing Roth IRAs.
- Moved programmatic charges out of your electric bill and created better oversight of new charges.

MAKING CONNECTICUT SENIORS A PRIORITY

- Ensured insurance coverage of biomarker testing to detect cancer early and improve treatment.
