

Survey Results

Dear Friends and Neighbors,

The 2019 legislative session is underway and I would like to provide you with an update on some of the issues and priorities my colleagues and I are working on. In odd numbered years, the General Assembly convenes in January, adjourns in June, and is referred to as the "long session." During this session, proposed bills from individual legislators aren't limited to matters concerning the state budget (anything tax or spending related). We can introduce any non-budgetary legislation we want. Of course, we also begin work on a new two-year state budget.

Some of the issues we are addressing, based on input from constituents, include: raising the minimum wage, and enacting earned family and medical leave.

The majority of working families support these priorities as well as new revenue streams to address structural deficits that won't involve cutting programs or raising taxes.

Recycling Clothing, Shoes & Accessories

Don't throw away your clothing, blankets, towels, & other textiles. Utilize the city's curbside Simple Recycling "Pink Bag" Program. Simple Recycling will follow the same schedule as normal recycling pick up times, and the company will leave a new bag each time a bag is collected.
