As part of our historic tax cuts, families of four who make \$50,000 annually will pay no state income taxes. This is another important step in making Connecticut affordable for everyone.

More importantly, we did it by working together - without partisan politics. We prioritized education, non-profits and invested in public safety without the fighting we often see in Washington.

GETTING PEOPLE BACK ON THEIR FEET

- Ensured those leaving prison have a state ID or driver's license
- Made more people convicted of a crime before the age of 21 eligible for parole
- Created reentry success plans for kids getting out of correctional or judicial facilities
- Expanded assistance to refugees
- Assisting people who no longer qualify for Medicaid by providing two months of premium assistance to enroll on the health insurance exchange
- Created pilot programs for substance abuse and mental health issues at correctional facilities
- Expanded eligibility to short-term financial assistance

SUPPORTING WORKERS AND SMALL BUSINESSES

- Required full disclosure of hidden fees on small business loans, ensured access to judicial hearings in a dispute, and required any loan offers to be good for at least three days
- Cut the number of reporting requirements for businesses
- Permanently allowed restaurants to sell alcohol for off-site consumption
- Supported CT farm wineries by allowing them to open up to three retail locations
- Protected workers whose health benefits are terminated by an employer following a strike or labor dispute
- Made it easier for small contractors to bid on state projects

HISTORIC FUNDING FOR OUR SCHOOLS

- Prevented any town from receiving a funding cut to their local schools
- Continued our commitment to funding local boards of education with an honest ECS formula
- Invested over \$240 million in public education for the 2024-25 school year including Open Choice, magnet schools, charter schools and vocational programs



A HELPING HAND TO COLLEGE STUDENTS

- Expanded debt-free community college including subsidies for returning students
- Created a Student Loan Ombudsman to help students, graduates, and their families deal with student loans
- Created a student loan reimbursement program, starting in July 2024, that will repay borrowers up to \$20,000 in student loan debt
- Established lower state-backed loan refinancing rates for licensed nurses with student loans
- Prohibited colleges and universities from withholding transcripts due to outstanding debt
- Stabilized our state colleges and universities

HELPING KIDS LIVE THEIR BEST LIVES

- Allowed trained childcare providers to administer EpiPens
- Required a state audit of all standardized testing
- Required boards of education to provide translator services and established rights for multilingual learners
- Required more play-based learning from pre-K to grade 5
- Created reimbursements to schools who purchase local foods for their school meals
- Required high school students to take a financial literacy class before graduating
- Banned child marriage
- Required funds from the state's legal settlement with vape-giant JUUL to go to helping kids under 21

IMPROVING HEALTHCARE

- Allowed over-the-counter drugs such as Narcan to be sold through regulated vending machines
- Expanded services for telehealth appointments
- Expanded pharmacy services to include vaccine administration of CDC immunizations, testing for COVID, flu, HIV, and preventative HIV treatment
- Established the Office of the Behavioral Health Advocate to help providers and patients navigate our insurance system
- Expanded workers' comp coverage for anyone who experiences PTSD at work
- Created a statewide Drug Discount Card Program, regulated pharmaceutical sales reps, and banned anticompetitive loopholes in healthcare contracts
- Created early detection screening for lung cancer
- Required newborn screening for cytomegalovirus
- Expanded coverage for gender-affirming care and strengthened protections for those who provide that care
- Created a harm reduction pilot program to prevent overdosesallowing people to access fentanyl and xylazine tests, receive counseling and other services
- Established a dedicated funding source for the bulk purchase of Narcan for towns, schools, local police and health departments and EMS companies
- Required the recommendation of Narcan when opioids are prescribed

PROTECTING RENTERS

- Increased municipal fines to \$2,000 for rental property violations like unsanitary or unsafe living conditions
- Required landlords to offer walk-throughs prior to signing a lease
- Capped rental application fees at \$50
- Erased judicial records for renters who win eviction cases
- Required more timely return of security deposits
- · Capped late charges for past due rent
