WINS FOR ROCKY HILL & WETHERSFIELD

FUNDING WE SECURED FOR THE 29TH DISTRICT

- \$600,000 to the Wethersfield Keene Foundation
- \$100,000 to the town of Wethersfield to support tourism
- \$250,000 for Rocky Hill Beach Road Flood Remediation
- \$2 million to Rocky Hill for the rehabilitation of senior housing on Willow Road
- \$4,400 to the Webb Deane Stevens Museum
- \$25,000 for the Rocky Hill Fire Department
- \$5 million for rehabilitation work at the West Street VA campus to add more housing for Veterans and their families
- \$55,000 for Planning and Engineering work at the Rocky Hill Senior & Disabled Housing



KEY LEGISLATION THIS SESSION

- Strengthened a variety of laws relating to the protection of children from sexual abuse
- The Office of Early Childhood (OEC) must now operate an early education system to coordinate and administer delivery of Early Start CT
- New legislation establishes a 10-member Education Mandate Review Advisory Council to advise and provide annual reports to the Education Committee on the (1) cost and implementation of existing education mandates on local and regional boards of education and (2) impact of proposals to add to or revise these mandates
- The legislature passed a law prohibiting foreign nationals from making contributions or expenditures under the state's campaign finance laws
- A new law gives towns the option of providing a partial property tax exemption for certain owner-occupied primary residences. This law specifically allows towns to exempt between 5% and 35% of the assessed value of owner-occupied single-family homes and duplexes (including condominiums and common interest community units)
- The new law for school bus passing violations requires towns adopting an ordinance to set the fine for violations at \$250 and process them through municipal procedures
- For excessive vehicle noise (i.e. illegal mufflers), the new law allows municipalities to adopt an ordinance establishing a vehicle noise limit of 80 decibels and authorizes the use of cameras to enforce the limit
- We now allow Copayment-Only Health Plans. Under this new law, insurance plan designs can get rid of the monthly premium and allow for co-pays only, saving customers on their annual health insurance costs
- Expanded the Insurance Commissioner's enforcement capacity



PRIORITIZING OUR SENIORS

- Created a new registry system to connect patients to home care providers and created a dashboard to help navigate the nursing options
- Prevented nursing homes from putting more than two patients in a single room
- Created an incentive-based program to improve nursing home care in CT
- Required retirement communities to provide at least 60-90 days'
 notice of any fee increases and improved transparency around fees
