REP. LINEHAN: BRINGING BACK CONNECTICUT'S ECONOMY

While our communities have faced devastating hardship this year, we are beginning to see brighter and stronger days ahead.

Connecticut has proven to be one of the top states to weather the Covid storm. The provisions put in place in the 2017 budget, like the spending cap and volatility cap, have paved the way for our brightest fiscal outlook in years. With an elevated bond rating, a budget surplus of over \$400M this year¹, and the rainy day fund at \$3.5B², we are set to make a sizable payment of an additional \$700M toward past pension debt. Additionally, CT is set to receive \$6.2B³ from the federal aid packages for our schools, small businesses, non-profits and more, including **\$40.5M for Cheshire, Southington, and Wallingford**.
