STATE REPRESENTATIVE RON NAPOLI JR.

A STRONGER WORKING CLASS

- Provided more low-and middle-income families a break on their state income tax through the Earned Income Tax Credit (SB 1202)
- Created a new workforce pipeline program for individuals with disabilities (SA 21-10)
- Expanded childcare services for parents who are working on their education (HB 6558)
- Created an Unemployed Workers' Advocate to assist out-of-work residents with accessing benefits and getting back to work
- Eliminated state income taxes on IRA income over time, beginning in the 2023 tax year (SB 1202)
- Repealed the poverty tax to stop the state from taking back cash and medical assistance from someone who works hard and pulls themself out of poverty (PA 21-3/SB 1202)

EQUALITY FOR ALL RESIDENTS

- Created a biennial study to better understand how we can reduce racial and economic segregation in CT (SB 1202)
- Joined seven other states in passing the "Crown Act", making it illegal to discriminate based on hair texture and hairstyle (PA 21-2)
- Guaranteed better rates on student loans for teachers in Alliance Districts so that we can help retain talented teachers and provide our students with equal educational opportunities



MORE AFFORDABLE HEALTHCARE

- Continued coverage for, and access to, telehealth so that we can make our healthcare system more efficient and flexible for all patients (HB 6470 & PA 21-9)
- Ensured dental coverage for kids through their parent's plans, up to the age of 26 (SB 1004)
- Set minimum standards for long-term care insurance (SB 2016)
- Provided better training and tools for police to respond to opioid overdoses (HB 1011)
- Lowered prescription drug costs by requiring manufacturing discounts go to the consumer and not the insurance company (PA 21-14)

SENIORS & VETERANS

- Ensured access to virtual visits and monitoring for nursing home residents and created a statewide policy on visitation (PAs 21-55 & 21-71)
- Required background checks at homemaker-companion agencies (PA 21-37)
- As Vice Chair of the Veterans' Affairs Committee, I helped increase funds to cover the cost of funeral expenses for fallen service members (PA 21-112)
- Established the National Purple Star School Program to assist families moving into the state with school registration, planning, counseling and other support services (PA 21-86)

MAKING OUR STREETS SAFER

- Fully funded state police training programs
- Secured \$6 million in additional grants for municipal police departments
- Put community violence prevention programs on a path to sustainable funding and growth in our state to serve more victims of gun violence and their families (PA 21-36)
- Working in a bipartisan fashion to address the car theft issues that have been plaquing communities all across the state
- Secured over \$50,000 for security upgrades to the Yeshiva School and \$5,000 for a local Youth Services Grant

RESPONDING TO COVID-19

- Expanded workers compensation benefits for PTSD to cover emergency responders, corrections workers, dispatchers and health care providers who were on the front lines of the COVID-19 pandemic (SB 660)
- Reformed nursing home staffing measures, policies, and supply inventories to ensure that our nursing homes remain safe and prepared in the case of future disease outbreaks (SB 1030)
- Strengthened numerous programs designed to keep people from losing their homes during tough times: Foreclosure Mediation, Lien Assistance and Emergency Mortgage Assistance (SB 891)
- Making sure our kids recover from this pandemic by expanding youth services prevention training, creating more outpatient services for kids, requiring social emotional learning as part of teacher professional development, and addressing absenteeism in virtual learning (PA 21-46)
