TAX RELIEF FOR CONNECTICUT & BUDGET HIGHLIGHTS



Representative Rochelle proudly supported the 2022 State Budget which provides a historic \$650 million in tax relief and makes vital investments in non-profits, child care, schools and more. This budget:

MIDDLE & WORKING CLASS RELIEF

- Lowers property taxes on cars from 37.80 to 32.46 mils meaning lower car taxes for you
- Increases the property tax credit from \$200 to \$300 and expands eligibility to all homeowners
- Eliminates the pension and annuity income taxes for a majority of retirees
- Establishes a CT Child tax credit for \$250 for each child, up to 3 children for middle and working class families
- Extends the 25 cent gas tax suspension
- Eliminates the sales and use tax for private water company customers
- Increases the Earned Income Tax Credit which will help over 1600 tax filers in Ansonia

FIRST RESPONDERS, SCHOOLS, NON-PROFITS AND BUSINESSES

- Pays volunteer fire companies \$500 for each call they respond to on designated highways including Route 8
- Allows EMS organizations to get a motor vehicle fuel tax refund for fuel used in ambulances
- Increases funding for police to address gun trafficking and car thefts
- Provides funding and guidance on maintaining the best indoor air quality in our public schools
- **Provides \$40 million** to the Unemployment Trust Fund to **help our state's businesses**
- Increases funding to address juvenile crime
- Not-for-profits that perform state functions will receive a 6.5% increase - this includes Team, Inc. and BHCare
