## SENIOR UPDATE

Representative Rochelle proudly supported all of the following bills this session:

## **PROPERTY TAX RELIEF EXPANDED**

HB 6458, An Act Lowering the Age of Eligibility for Property Tax Relief for Senior Citizens and Establishing a Task Force to Protect Senior Citizens from Fraud, gives towns the ability to lower the age to provide property tax relief for seniors to 65, and as described, creates a task force to prevent fraud targeted at seniors.

#### PHASING OUT THE INCOME TAX ON PENSIONS AND ANNUITIES

HB 6689, An Act Concerning the State Budget, continues to phase out the state income tax on pensions and annuities - exempting an additional 28% over the next 2 years, which will exempt in total 70% of this income from state taxes for most seniors.

## **BANNING AGE DISCRIMINATION**

SB 56, An Act Deterring Age Discrimination in Employment Applications, prohibits age discrimination during the employment application process.

### **RIGHTS OF NURSING HOME RESIDENTS EXPANDED**

HB 6457, An Act Concerning Access to Recordings and Images from Technology Used by Nursing Home Residents for Virtual Visitation and Virtual Monitoring, expands the rights of nursing home residents and ensures they can use technology to facilitate virtual visits with family and friends.

### LONG TERM CARE INSURANCE

SB 1046, An Act Concerning Long Term Care Insurance, puts in place strong consumer protections on long-term care insurance to prevent significant, unexpected rate increases and ensures more affordable products are available.
