2022 – a banner year. My colleagues and I enacted legislation that puts money back in your pocket with more income tax cuts for retirees, acceleration of pension and annuity income tax exemption, bigger state income tax breaks for more homeowners, increases in the property tax credit and expansion of the number of taxpayers who can claim the credit and gas tax relief. The state budget includes a whopping \$650 million in tax relief. All while boosting CT’s fiscal health with reductions in pension liabilities and maintaining a robust rainy-day fund.

But I am always mindful of the toll these past years have taken on all of us. We passed laws focused on children’s mental health needs and juvenile justice reform. We made CT a true champion of women’s reproductive health. We moved forward with initiatives to make CT a leader in green growth. We continue to make voting more user friendly with increased availability of absentee ballots.

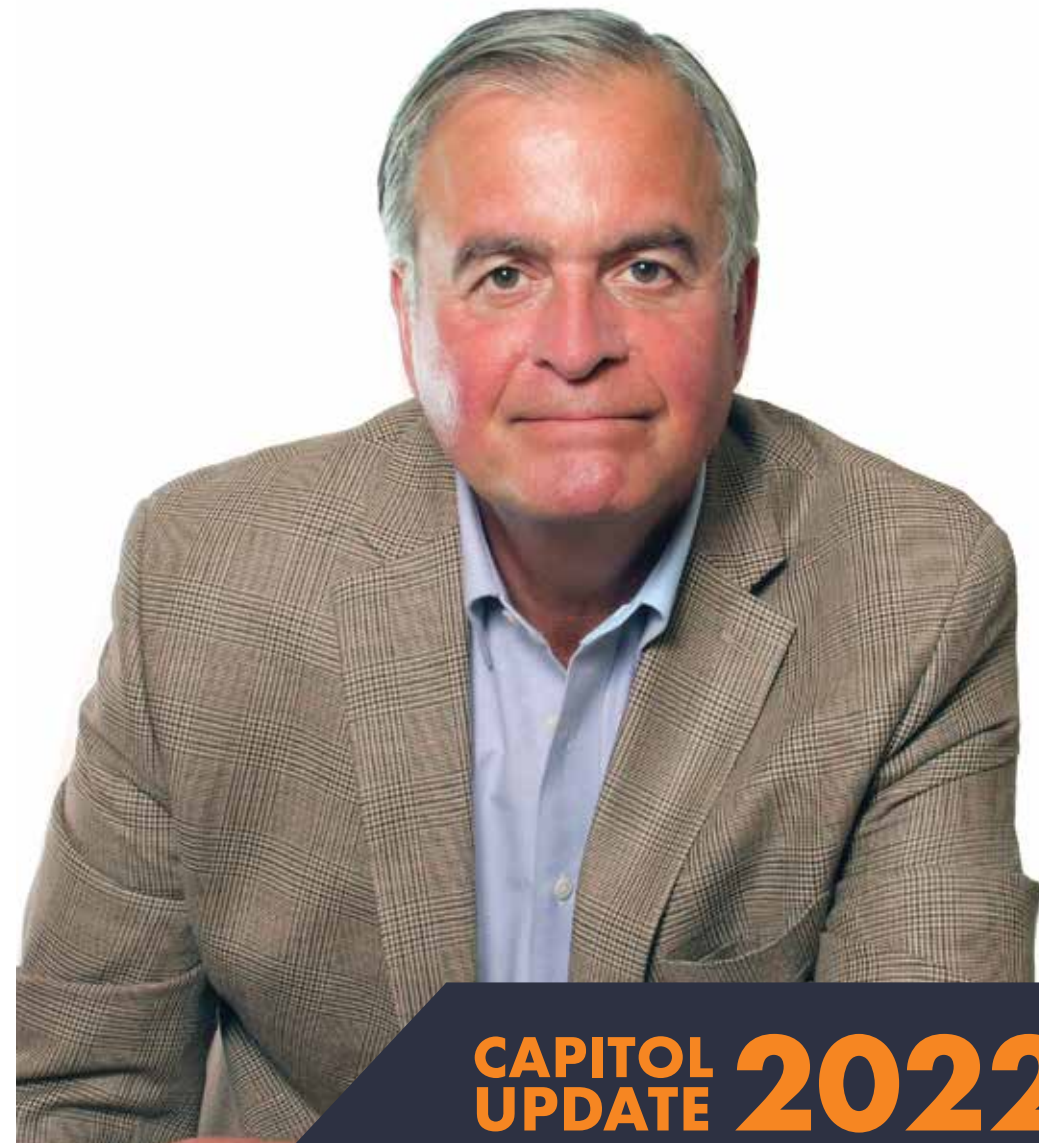
