Dear Neighbors,



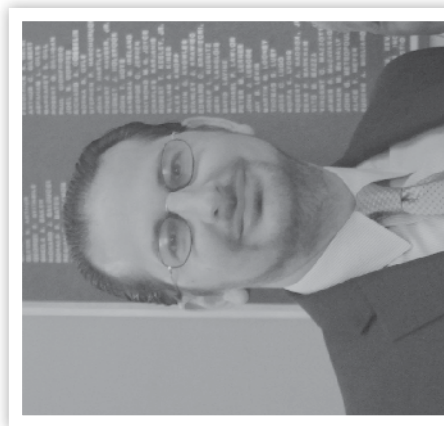
